### VISITORS AND GUEST REMARKS

Mr. Davis spoke out against mask mandates.

Ms. Fowler identified discrepancies and concerns that has resulted in her feelings of mistrust towards JCHD and the state and called for more transparency in business dealings, improved accuracy in data reporting, and greater consistency in following the agency's internal mask mandate.

### APPROVAL OF TAX RATE

Mrs. Vollmar proposed the tax rate for 2020 as 0.1073 per \$100 assessed evaluation. The anticipated JCHD revenue would be \$3,788,006. Mrs. Davis asked what the current tax rate was to which Mrs. Vollmar reported it is the same. Mr. Pigg asked if this is what is set by the state to which Chairman Diehl replied, "Yes, this is what comes down from the state. Every year the Hancock Amendment determines whether or not there should be a changed based on change of property value. So this is how all the numbers are determined right now; although, it's the board's responsibility to approve that or not." Mrs. Davis asked if this proposal would raise residents' taxes to which Chairman Diehl clarified it would not.

Mr. Pigg made a motion to accept the proposed tax rate for 2020 as 0.1073 per \$100 assessed evaluation. Mr. Prater seconded. Chairman Diehl put the motion to vote by roll call. The responses were as follows:

Chairman Diehl: Aye

Dr. Henry: Aye Mr. Pigg: Aye Mr. Prater: Aye Mrs. Davis: Aye

Chairman Diehl announced the motion passed and the tax rate was set for 2020.
